





Critical Item Trends

Annual Pre-Post Change Trends

This section provides an overview of the trends in pre-post CCAPS-34 change for your center. Change is calculated as the difference between each client's first and last CCAPS of each year, with positive values indicating improvement (reduction in scores).

Annual sample sizes

The following table provides the number of clients with at least two CCAPS-34 administrations each year at your center and in the national data. This table provides context for interpreting the graphs that follow. This table also includes a column indicating the percentage of clients at your center who had multiple (i.e. at least two) CCAPS-34 administrations each year.

Years where the number of clients at your center seems comparatively low or where the percentage of clients with multiple CCAPS is low may be due to the CCAPS being used mainly at baseline and not at repeated measures during treatment. For Titanium users, low number of clients in older years may also be due to data being partially purged from Titanium for older years, indicating that the data available does not represent the entire sample for that year.


The following table and graphs summarize average CCAPS-34 pre-post change scores by year. The graphs display trends for your center compared to national data (graphed in grey). Data points for your center that are lighter/more transparent represent years where the number of clients is low, and data should be interpreted cautiously.

Average pre-post change is most accurate for centers that are administering the CCAPS at every session. Other CCAPS administration schedules may result in pre-post data that does not capture the full treatment for all clients (e.g. administering the CCAPS at 1st and 3rd sessions does not capture the full treatment for clients who attend 5 sessions).


Additionally, pre-post change is influenced by average baseline scores. Centers with lower average baseline scores (see baseline CCAPS-34 section) may have less room for improvement and thus may have smaller pre-post change scores.







Average CCAPS-34 Academic Distress Pre-Post Change Scores by Year




Average CCAPS-34 Eating Concerns Pre-Post Change Scores by Year






