Each year, the number of neurodivergent students in higher education continues to grow (ACHA, 2025), necessitating a shift in the way we approach counseling and mental health support in a collegiate setting. So, how do mental health professionals make small changes to their procedures, individual and group sessions?

This webinar will demystify the concept of neurodivergence by clarifying the terminology related to neurodivergence, discussing the neurotypes included under the neurodivergent umbrella, and exploring the strengths and challenges experienced by neurodivergent college students.

Dr. Jennifer Pusateri will share some counseling considerations that are specific to neurodivergent college students and provide several actionable “next-day” strategies that mental health professionals could begin utilizing right away in their practice to support their neurodivergent clients.
